

### **Solace Sauna Privacy Policy**

This Privacy Policy explains how Solace Sauna collects, uses, and safeguards your personal data when you interact with our services, including visiting our website or making bookings.

#### Who We Are

Solace Sauna is a Limited Company registered in England. We are committed to protecting your privacy and handling your personal data in accordance with all applicable data protection laws, including the UK General Data Protection Regulation (GDPR).

#### **Personal Information We Collect**

We may collect and process the following categories of personal information:

- Contact and Identification Details: This includes your name, postal and email addresses, telephone number(s), and preferences when you make an enquiry or booking.
- Usage and Attendance Details: We may collect information such as your IP address, browser type, and the URL you used to access our site. We also record details of your sauna booking.
- Correspondence and Incident Reports: Any communications or incidents at our sauna will be recorded for reference and safety purposes.
- **Payment Information:** We process and securely store your payment details to facilitate your transactions with us.
- **Personal Circumstances:** In some cases, such as to handle cancellations due to illness, we may collect information related to your health or medical conditions.

#### **How We Use Your Personal Information**

We use your personal data for the following purposes, relying on our legitimate business interests and contractual obligations. Here's how we use each category of information:

- Contact and Identification Details: To manage enquiries, process bookings, and communicate updates or offers related to our services.
- **Payment Details:** To process payments for our services and assist in resolving disputes or collecting debts if necessary.

We may also use your data for any other purposes described at the point of data collection, and we will always seek your consent if processing special categories of personal data such



as health-related information. If you do not wish to provide this information, you may be unable to use our services.

#### **How We Collect Your Data**

We collect personal data from you through several channels, including:

- **Booking and Enquiries:** When you complete a booking or enquiry on our website, we collect the necessary details to manage the request.
- **Email and Telephone:** Data is collected when you contact us via email or phone, and this information is stored for legitimate business purposes and to improve service delivery.
- Cookies and Web Analytics: Our website uses cookies and similar tools, such as Google Analytics, to track how visitors use our site. This information is aggregated and anonymised and helps us improve site performance and tailor services to customer preferences.

We do not sell or trade your personal data. However, we may share your information with trusted third parties to help deliver our services, including:

- **Legal and Fraud Protection Entities**: If necessary, for legal claims, fraud prevention, or credit risk reduction.

#### **Retention of Your Personal Data**

We retain your personal data only for as long as necessary to fulfil the purposes it was collected for:

- **Incident Details**: For three years after an incident.
- **Contact and Identification Details:** Retained for up to four years after your last booking or enquiry.
- Communication Preferences: Indefinitely to avoid sending unwanted information.
- **Payment Details:** Stored securely during and for a short period after the transaction, unless required for dispute resolution.
- Correspondence and Incident Reports: Retained for up to seven years for legal and safety compliance.
- Cookies and Analytics Data: Retained based on cookie lifespan and analytics requirements, often anonymised.

In some cases, we may retain data longer if required by law or in the event of an ongoing dispute.

### **Your Rights**

Under data protection laws, you have the following rights in relation to your personal data:

- Access: You can request a copy of the data we hold about you.
- Correction: You can ask us to correct any inaccurate information.
- **Portability:** You can request your data in a portable format.
- Erasure: You can request that we delete your data under certain circumstances.



• **Restriction of Processing:** You can ask us to limit how we process your data where applicable.
